#### **RESEARCH INTERESTS**

Democratic theory; deliberative democracy; multiculturalism; gender; race; disability; historical (in)justice; facilitation; quantitative methodology; experimental methodology

My research agenda explores the challenges, opportunities, and best methods of inclusion and representation of marginalized communities in democratic decision-making processes. In my book project, I examine whether people are willing and capable of engaging in deliberations with those with whom they disagree on issues that touch upon their cultural and religious identities. In particular, I devised and, through experiments, tested the efficacy of two facilitation methods in increasing the capacity of participants to participate in a respectful, reflective, and constructive way. While I found some evidence of unwillingness for participation in deliberations that can challenge the cultural and religious identities of participants, the facilitative methods were both highly successful at increasing discourse quality by limiting the instances of engagement in undesired behaviours. Currently, I am expanding this research to consider the likelihood and longevity of opinion change as a result of deliberation when different facilitative methods are used.

I served as the consultant during the research and development phase of a series of deliberative minipublics on electricity utilities. The aim of the mini-publics would be to recruit customers, and provide feedback on key planning questions facing electricity utilities. The core debate was over the right balance between affordability and reliability but it also concerned customer services issues as well as the design of customer tools. My job was to provide expert knowledge on deliberative democratic practices. I put together and presented a report on a number of key issues: what makes good and bad deliberative process; what factors are key in determining recruitment; what kind of information needs to be provided and how; what considerations should be kept in mind in formatting the process; what lessons we can learn from both successful and unsuccessful deliberative process; and what are the best methods of facilitation of such conversations.
